#### 1. Personal Data We Collect

We collect personal data only when you voluntarily provide it through our contact or request forms. This may include:

- Name
- **Email address**
- Phone number
- Company name
- Any other information you choose to provide in your message

In addition, we use Google Analytics (GA4) to collect non-identifying analytical data about website usage.

#### 2. How We Use Your Personal Data

We process the data submitted through our forms solely for Drillmasters' commercial purposes, including:

- Responding to your inquiries
- Preparing and sending quotations or information
- Providing customer support
- Maintaining business communication

Analytical data collected via Google Analytics is used only to analyze website performance and user behavior. We do not use Google Analytics data for active marketing or advertising targeting.





## 3. Legal Basis for Processing

We process your personal data based on:

- **Legitimate interests** (Article 6(1)(f) GDPR): to communicate with customers and improve our services.
- Consent (Article 6(1)(a) GDPR): when you voluntarily submit information through our forms.

### 4. Data Sharing

We do not sell or share your personal data with third parties except:

- Service providers, such as Google Analytics, that assist in analyzing website usage.
- When required by law or to comply with legal obligations.

All third parties are required to handle your data securely and in compliance with the GDPR.

## 5. Google Analytics (GA4)

We use Google Analytics (GA4) to gain insights into website traffic and usage patterns. GA4 may collect information such as:

- Device type
- Browser type
- Pages visited
- Time spent on pages
- Approximate geographic location (not precise)

Google may process this data on servers located in the EU or the United States. We do **not** enable advertising features or link analytics data with identifiable users.

#### 6. Data Retention

We retain personal data only for as long as necessary to fulfill the purposes for which it was collected, including compliance with legal, accounting, or reporting requirements. Analytical data from Google Analytics is retained according to GA4's configurable retention periods.

You have the following rights regarding your personal data:

- Right of access to request a copy of your data
- **Right to rectification** to correct inaccurate or incomplete information
- Right to erasure to request deletion of your data
- Right to restrict processing
- Right to object to processing based on legitimate interests
- Right to data portability
